The property is zoned CD-22 (Comprehensive Development-22) which permits the existing business as a neighbourhood pub. The portion of the property subject to the application is located within the existing ground-floor commercial unit and patio area, and as such, the increased hours of operation are not anticipated to increase noise, parking or traffic to levels greater than what is currently experienced. The [Community Standards Bylaw 2021, No. 5041](#) will be in effect and in force, from time to time.

As the business is located within an established commercial area with a variety of uses, including other brewery establishments, it is anticipated to continue to integrate into the existing neighbourhood with minimal impact to the surrounding land uses.
