- **10.** There are hereby imposed rates for Potable Water Filling Station usage as set out in Schedule "G" attached to and forming part of this bylaw. (AB#4710)
- **11.** There are hereby imposed rates for Serviced Food Truck Vending Location Permit Fees as set out in Schedule "H" attached hereto and forming part of this bylaw. (AB#5029)

12. There are hereby imposed rates for Crime Prevention Services as set out in Schedule "I" attached hereto and forming part of this bylaw.

<u>e.</u>	Referrals made by Victim Services	No charge
<u>f</u> .	Referrals made by the RCMP	No charge

* CPTED services are not provided for new building projects. These services can be found in the community by other authorized CPTED licensed organizations.

2. Fees for participation in the Crime Free Multi-Family Housing Program shall apply as follows:

a. Multi-Family Residential Housing with 30 units or less \$450

b. Multi-Family Residential Housing with 31 units or more \$600
