City of Chilliwack

Bylaw No. 5288

A bylaw to amend the "Zoning Bylaw 2020, No. 5000"

The Council of the City of Chilliwack in open meeting assembled enacts as follows:

- 1. This bylaw may be cited as "Zoning Bylaw Amendment Bylaw 2023, No. 5288".
- 2. "Zoning Bylaw 2020, No. 5000" is hereby amended in Section-2 DEFINITIONS, Subsection 2.01 DEFINITIONS USED IN THIS BYLAW, by inserting the following new definitions, in alphabetical order:

"CANNABIS CONSUMPTION SPACES

means a business, special event, or other establishment providing cannabis for sale and use onsite;

TRADESPERSON

means a trades contractor or other professional (related to the construction industry) or a contractor who performs maintenance and/or repair of land and buildings from other than their premises;"

- 3. Said Bylaw is hereby further amended in Section-2 DEFINITIONS, Subsection 2.01 DEFINITIONS USED IN THIS BYLAW, GENERAL COMMERCIAL, by inserting a new Paragraph (y), as follows, and re-alphabetizing the existing paragraphs accordingly:
 - "(y) TRADESPERSON"
- **4.** Said Bylaw is hereby further amended in Section-4 GENERAL PROVISIONS, Subsection 4.03 USES PROHIBITED IN ALL ZONES, Paragraph (1), by adding a new Subparagraph (i), as follows:
 - "(i) Without limitation, CANNABIS CONSUMPTION SPACES"
- 5. Said Bylaw is hereby further amended in Section-4 GENERAL PROVISIONS, Subsection 4.08 REGULATIONS APPLICABLE TO SPECIFIC ZONES, Paragraph (6) AMENITY AREA STANDARDS, by deleting Subparagraph (c) in its entirety, and realphabetizing the existing subparagraphs accordingly.
- 6. Said Bylaw is hereby further amended in Section-4 GENERAL PROVISIONS, Subsection 4.09 FENCING, LANDSCAPING, SCREENING, Paragraph (2) LANDSCAPING, Subparagraph (b) LANDSCAPING FOR MULTI-UNIT AND INTENSIVE RESIDENTIAL DEVELOPMENT, by deleting Clause (iv) in its entirety.

- 7. Said Bylaw is hereby further amended in Section-5 PARKING REQUIREMENTS, Subsection 5.04 MINIMUM OFF-STREET PARKING SPACE REQUIREMENTS, Column "INDUSTRIAL USE", by deleting the words "SERVICE INDUSTRIAL" and substituting with the word "TRADESPERSON" before the words "RESEARCH AND"; and further, by inserting the words "SERVICE INDUSTRIAL" before the words "LIGHT MANUFACTURING".
- 8. Said Bylaw is hereby further amended in Section-10 INDUSTRIAL ZONES, Subsection 10.01 M1 (LIGHT INDUSTRIAL) ZONE, Paragraph (1) PERMITTED USES, by inserting a new Subparagraph (d), as follows, and re-alphabetizing the existing subparagraphs accordingly:
 - "(d) TRADESPERSON"
- 9. Said Bylaw is hereby further amended in Section-10 INDUSTRIAL ZONES, Subsection 10.03 M2 (SERVICE INDUSTRIAL) ZONE, Paragraph (1) PERMITTED USES, by inserting a new Subparagraph (e), as follows, and re-alphabetizing the existing subparagraphs accordingly:
 - "(e) TRADESPERSON"
- 10. Said Bylaw is hereby further amended in Section-13 COMPREHENSIVE DEVELOPMENT ZONES, Subsection 13.10 CD-10 (COMPREHENSIVE DEVELOPMENT-10) ZONE, Paragraph (1) PERMITTED USES, by inserting a new Subparagraph (f), as follows, and re-alphabetizing the existing subparagraphs accordingly.
 - "(f) TRADESPERSON"
- 11. Said Bylaw is hereby further amended in Section-13 COMPREHENSIVE DEVELOPMENT ZONES, Subsection 13.12 CD-12 (COMPREHENSIVE DEVELOPMENT-12) ZONE, Paragraph (1) PERMITTED USES, by inserting a new Subparagraph (g), as follows, and re-alphabetizing the existing subparagraphs accordingly.
 - "(g) TRADESPERSON"
