

To amend the 2040 Official Community Plan designations for the subject properties, as shown on the map below, from 'Urban Quarter' and 'Residential 4' to 'Institutional and Civic Use' as per the Downtown Land Use & Development Plan; and, to rezone the properties from the C3 (Town Centre Commercial) Zone, R2 (Urban Residential Transition) Zone, and the R6 (Mid Rise Apartment) Zone to a CP (Commercial Parking) Zone, to

facilitate construction of a parking lot.
